



# PARTITION MOUNTED DUAL TWIN HIDE-A-ROLL TOILET PAPER DISPENSER




HOLES BOTH **FLANGES**

## **SPECIFICATION**

Partition Mounted Dual Twin Hide-A-Roll Toilet Paper Dispenser shall hold and dispense four (4) standard or four (4) 5-1/4" Dia [Ø133] 1800 sheet tissue rolls and shall have doors, door frames, and dispensing mechanism guide tracks of 18 gage [1,3] type 304 stainless steel alloy 18-8. Cabinet bodies and mounting flanges shall be 22 gage [0,8] same grade. Face trim mounting flanges shall be of one-piece construction 1" [25] wide with no welded miters and shall have square 1/4" [6] returns to partition. All exposed surfaces shall be satin finish and be protected during shipment with PVC film easily removable after installation. Internal mechanism levers shall be molded high -impact resistant plastic for smooth operation. Structural assembly of body and door components shall be of welded construction. Door hinges shall be heavy-duty stainless steel 3/16" Dia [Ø4,8] rivets. Doors shall be held closed with tumbler locks keyed alike to other ASI washroom equipment. Cabinet shall include two (2) theft and vandal resistant rollers (p/n R-004) that are molded high-impact resistant plastic with integral molded-in plated steel endpins.

Partition Mounted Dual Twin Hide-a-Roll Toilet Paper Dispenser shall be Model № 0032 as manufactured by American Specialties, Inc. 441 Saw Mill River Road Yonkers, New York 10701-4913

### **INSTALLATION**

Partition mount unit through precut partition cutout (PCO) using four (4) № 10 x 3/4" [M5 x 20] Philips flat-head or oval-head self-threading screws (supplied) per side {eight (8) total} through mounting holes provided through fixed mounting frame and adjustable mounting frame into suitably prepared partition (by others). Mounting holes are offset 1/2" [13] from opposite side frame holes for screw clearance. Mounting flanges adjust to accommodate partition thickness of 1/2" [13] min to 2-1/2" [64] max. For compliance with 2010 ADA Accessibility Standards and 2015 ABA Standards install unit with axis of bottom roller 15" [381] min AFF (Above Finished Floor) to 48" [1219] max AFF and centerline of dispenser shall be 7" [178] min to 9" [229] max in front of toilet.

PCO Required is 12-1/8" [308] W x 12-1/4" [13] H x 1/2" [13 ] to 2-1/2" [64] Thick

Reloading instructions are printed on graphic labels inside doors. Bottom roll is depleted prior to top roll automatically dropping into lower position for use. Empty rollers cannot be removed without key unlocking door. Individual two-roll dispenser is accessible from each side of partition.
